

DU LLM International Law – DUA771

Calendrier de la formation : du 2 novembre 2023 au 02 juillet 2024 (date délibérations, toutes les notes doivent être rendues une semaine avant)

Courses must take place between November 2, 2023, and June 15th, 2024.

Forme de l'enseignement : hybride, les cours se déroulent sur place à la Faculté de droit ou à distance mais ils sont toujours enregistrés (voir contrat pédagogique et mise en œuvre).

Form of teaching: hybrid, courses take place on campus at the Faculty of Law or at a distance but are always recorded (see pedagogical agreement and its implementation).

Rythme de formation : les cours peuvent se dérouler idéalement une matière après l'autre, suivant un rythme et des créneaux choisis par l'intervenant (plusieurs sessions par semaine peuvent être organisées, de préférence aux horaires « creux » entre 11h et 14h ou à partir de 18h pour faciliter la présence des stagiaires inscrits dans d'autres formations ou exerçant une activité professionnelle).

Pace of training: courses can ideally take place one subject after the other, according to a rhythm and time slots chosen by the trainer (several sessions per week can be organised, preferably at "off-peak" times between 11 a.m. and 2 p.m. or from 6 p.m. onwards to facilitate the presence of trainees enrolled in other training courses or who have a professional activity)
