Course description:

This course offers students the opportunity to approach international courts and tribunals both in theory and practice. The first part of this course provides an overview of the various international courts and tribunals, their jurisdiction and applicable law, and the main procedural rules as well as a presentation of practical aspects of litigation before these courts and tribunals. The second part is a mock trial concerning a concrete interstate dispute. Divided into two groups, students will be asked to draft a memorial exposing the arguments of the party they represent and will then present their arguments orally before a panel of professors. Students will be guided by the instructor throughout the preparation of both the written and oral pleadings.

Course learning outcomes:

Upon completion of this course, students will demonstrate their ability to:

- analyze and qualify in law the facts of a concrete case.
- draft written pleadings.
- prepare and deliver oral pleadings.

Student evaluation plan:

The evaluation will be based upon the students' work on the memorial and on their oral presentations.
